**PROPOSED UPDATES TO THE ADMINISTRATIVE PLAN FOR THE SECTION 8 HOUSING CHOICE
VOUCHER PROGRAM (HCV)**

The Bridgeport Housing Authority d.b.a. Park City Communities (PCC) is soliciting public review and comment on the proposed updates to the Section 8 Housing Choice Voucher Program's Administrative Plan in compliance with the U.S Department of Housing and Urban Development (HUD) Rule (24 CFR Part 903 and 982.54), and Public and Indian Housing (PIH) Notice 2016-05. The proposed Administrative Plan will be available for public review for a period of 45 days beginning Wednesday **April 6, 2019** and commencing on **Thursday May 23, 2019**.

The Administrative Plan establishes local policies for administration of the Section 8 Housing Choice Voucher Program in accordance with HUD requirements. The Administrative Plan, and any revisions to the Plan, must be formally adopted by the PHA Board of Commissioners or other authorized PHA officials. The Board will be considering updates to the Administrative Plan both mandated by HUD and matters with which the PHA has discretion to administer local housing policies. The Administrative Plan must be available for public review and comments on the proposed Administrative Plan updates are requested and encouraged.

The proposed updates to the Administrative Plan for the Section 8 Housing Choice Voucher Program is available for review at Park City Communities (PCC) Executive Offices 150 Highland Avenue, Bridgeport, CT 06604 or at any PCC's Administrative offices/Public Housing property management offices (Refer to PCC website for addresses: www.parkcitycommunities.org).
